Acting on a resolution submitted and signed by seventeen members of the Society, Dr. Carl Hering was unanimously elected to honorary membership. Dr. Hering is one of the founders of the Society and has served the Society in a most unselfish and generous way. He has ever carried at heart the welfare and best interests of our Society. He has contributed lavishly to our Transactions and is recognized as one of the fore-

Mr. F. A. J. FitzGerald moved that a Set of Rules for Authors be drawn up. The motion was carried and Mr. FitzGerald requested to confer with the members of the Publication Committee and to submit a draught of such rules at one of the next Board Meetings.

The subject of a Prize Fund was discussed and Mr. Acheson Smith appointed a committee of one to investigate the proposition and to report back to the Board.

To further increase the income of the Society Dr. Fink suggested utilizing a part of the space in the Bulletin for advertising purposes. After considerable discussion, the motion was lost.

The place of the Fall Meeting was next considered. After reviewing the various proposals and invitations. Montreal was definitely decided upon and Mr. Tone was appointed a Committee of One to arrange for a suitable date. Mr. Tone later reported that September 21, 22 and 23 was found to be most convenient. The headquarters will be the Hotel Windsor. No definite place for the Spring meeting of 1923 was decided upon.

Through the personal efforts of President Smith the accounting firm, Miller, Franklin, Basset & Co., carefully audited the Society's accounts and submitted a detailed report. They also outlined a simple system of accounting which will place the books and records on a profit and loss basis. It was moved and unanimously seconded that a vote of thanks be extended to the firm. It was further moved that the system outlined by Miller, Franklin. Basset & Co., be rigidly adhered to hereafter.

A resolution to increase the membership dues to \$8.00 per annum, signed by fifteen members of the Society, was presented and

It was moved and carried to submit the question to the membership at large. A card will be enclosed with

A communication was read from Dr. Allen Rogers, Secretary of the Society of Chemical Industry, American Section, requesting the American Electrochemical Society to submit to him the names of two chemists residing in the United States whom we consider worthy of the PERKIN MEDAL. It was suggested that the membership at large be asked for suggestions and that the substance of Dr. Rogers' letter be printed in the next white

The Committee on Ways and Means, H. B. Coho, Chairman, submitted a preliminary statement. Various suggestions were included for increasing the revenue of the Society and thereby enlarging its scope of usefulness.

In a letter directed to the Board, Mr. M. J. Fessler, of Poughkeepsie, urged the formation of an "Organic Electrochemistry Division." It was ordered to canvass the membership at large by mail to ascertain whether or not there are enough members interested in this subject to warrant the formation of a division. A blank post card will be mailed together with the next white Bulletin.

The Committee on Subjects for Future Symposiums, F. A. Lidbury, Chairman, reported the following sub-

(1) Conductivity of Electricity through Gases.

(2) Uses of Steel and Iron Additions.

(3) Endosmosis and Cataphoresis.

(4) Electrolytic Iron.

(5) What Electrochemistry has done for Radio Telegraphy and Telephony.

After due deliberation the Board decided upon subject No. 3 for the Fall meeting and asked Mr. Lidbury to confer with Dr. Bancroft and others and ascertain whether or not sufficient material is available for a session. Should this not be the case, it was decided to arrange for a symposium on the Conduction of Electricity through Gases. The Electrothermic Division reported that they were soliciting papers on "INDUSTRIAL HEATING" for the Montreal Meeting and on "THE PRODUCTION AND APPLICATION OF THE RARER METALS" for the Spring 1923 meeting. The Electrodeposition Division reported that they would cooperate with Mr. Lidbury in ascertaining whether or not the subject of Endosmosis could be launched for the Montreal Meeting; for the Spring Meeting, 1923, the subject "ELECTRODE POTENTIAL" had been selected.
