In 1893, in addition to being Electrical-Engineer-in-Chief, assumed general charge of the Contract department of the Company. In 1897 became General Superintendent' of the Chicago Edison and Commonwealth Electric Companies. These two companies control practically all of the central station lighting and power business in the City of Chicago. As General Superintendent had full direction, reporting to the President, of the Operating, Electrical Engineering, Construction, and Contract departments of the Companies, in fact, all departments except the Accounting and Merchandise Sales. Continued as General Superintendent until July, 1902, at which time was elected by Board of Directors to the position of Second Vice-President of the Chicago Edison Company and Commonwealth Electric company, which position I now occupy. As Second Vice-President, have supervision,

charge and control of the Operating, Construction, Electrical
Engineering and Contract departments of the Companies' business.
(The Board of Examiners are undoubtedly familiar with the general
character and proportions of the electrical engineering work of
these two Companies, and I will not, therefore, enter into spe-
eific details, unless it is desired.)

Edison Company, and designed extension of their system into the
residence district. Acted as Consulting Electrical Engineer for
