I believe you are already informed that Professor Harris J. Ryan has accepted the first Iwadare Fund Lectureship and is coming to Japan during next October to deliver a series of lectures on electrical engineering subjects.

The Institute of Electrical Engineers of Japan has recently formed the Professor Ryan's Reception Committee to deal with various working programs relating to his receptions, lectures, inspection trips, sight-seeings, etc., and Mr. M. Shibusawa has been appointed the Chairman.

Dear Mr. Hutchinson:-

I was very much interested to receive your letter of July 7th, enclosing copy of a letter from Mr. Shungo Furui and a clipping from the A.I.E.E. Journal of February 1927, all referring to the proposed visit of Professor Ryan to Japan next October.

I very much regret that I am unable to be of very much assistance in this connection but I am enclosing two clippings from the Daily Palo Alto Times of May 29 and 30 with reference to Professor Ryan's coming retirement on September 1st of this year. These clippings were handed to me by mutual friends and acquaintances who have recently returned from the Pacific Coast and you may find them of possible interest.

Questions 4 and 5, referring to his early education and scholastic honors, seem to be fairly well covered by the information given in the clippings. I am also enclosing herewith a description of the Harris J. Ryan High Voltage Laboratory, and from which you will be able to obtain a partial list of publications on high voltage investigations in answer to questions No. 8 and 9.


Unfortunately I am unable to give you any authoritative information in regard to Professor Ryan's lineage as requested in questions No. 10 and 11 and I am rather inclined to believe that Prof. Ryan is not particularly "strong" in the investigation and publication of this subject. I can speak with more assurance, however, in regard to Mrs. Ryan's "lineage", questions No. 12 and 13 and about the only thing that I can suggest authoritatively, in answer to these questions, is that she is the sister of a "poor but hopeful" engineer now employed by the General Electric Company.

A list of prominent, American, electrical engineers who have received their education from him, question No. 16, would be a long one and can best be answered by a reference to the engineering graduates from Cornell and Stamford since 1889 and 1895 respectively.

For your own personal, entirely unofficial, information, I would like to add that I had a letter from Professor Ryan about a month ago in which he stated that they had practically decided not to make the Japanese trip this fall. It seems that Professor Ryan feels that he is very much in need of absolute rest and quiet for some time and that the trip to Japan has therefore been more or less indefinitely postponed. This statement should be considered as confidential and not for transmission in any way to the Japanese officials who are preparing for his expected visit in October. I feel that any such decision should come direct from Professor Ryan himself, and hence this request.

I am returning herewith the clipping from the A.I.E.E. Journal, as requested, and very much regret that I am unable to be of any further assistance in connection with this matter.
