My dear Professor Ryan:

Your communication of the 8th inst., addressed to the Board of Directors of the Institute requesting that action upon your application for transfer to the grade of Fellow under the Special Section of the Constitution be deferred, was received yesterday, and was presented at the meeting of the Board held yesterday afternoon. I was directed by the Board to withdraw your application for transfer in accordance with your request; otherwise, you would have been transferred to the grade of Fellow at yesterday's meeting of the Board of Directors, as your application had been approved by the special committee to which all applications for transfer under the special section of the Constitution are referred, and was included in the report made to the Board of Directors by that committee yesterday morning.

I note that you desire to renew your application when the regular and not the special section requirements of the Constitution are in force.

I am, therefore, sending you herewith the proper form for making an application under the regular section of the Constitution. This application can be made at any time as these sections of the Constitution are in force at present; that is, it is not necessary for you to wait until after May 1st, which is the last date upon which applications under the special section can be made.

Subject: Proposed Transfer of Mr. Harris J. Ryan to grade of Fellow

Attention: Mr. Farrer

At the recent Annual Convention, Mr. N. A. Carle stated that during his recent visit to California, he learned from other Institute members that Professor Harris J. Ryan has never applied for transfer to the grade of Fellow because he fought the constitutional amendment to create the grade of Fellow. Therefore, he feels that it would be inconsistent for him to apply for this grade. Prominent members in California, however, inform Mr. Carle that in their opinion Mr. Ryan would appreciate being transferred to the grade of Fellow, and Mr. Carle, therefore, suggests that we present the matter informally to the Board of Examiners of the Institute and ask whether or not they would place Mr. Carle in a position to take the matter up as an individual with Professor Ryan, or some of the California members, transmitting an application for transfer made out from the information that we have in this office, so that all Professor Ryan has to do is to sign his name to it, and return it to this office.

Please prepare such a tentative application, and take the matter up with the Board of Examiners at its next meeting. Then advise Mr. Carle what view was expressed, at the same time transmitting him a tentative application.

On January 16, 1913, Professor Harris J. Ryan made application for transfer from the grade of Member to that of Fellow (Special Section), as follows:

I hereby apply for transfer from the grade of Member to that of Fellow under the Special Section of the Constitution, adopted May 21. 1912.

My age is 47 years.

I consider myself eligible for transfer under Clause (b), Section 4, of the Constitution.

The specific work upon which my application is based covers a period of 25 years.

Dear Sir:

In connection with the request for transfer to the grade of Fellow of Harris J. Ryan, Professor of Electrical Engineering, Stanford University, I am returning herewith the form for the information of the Board of Examiners. Professor Ryan received his education at Baltimore City College, and Lebanon Valley, and later was graduated from Cornell University with the degree of M.E. He was a member of the Western Engineering Company of Lincoln, Neb., in 1888, and was made instructor in charge of the electrical machinery laboratory in Cornell University in 1889. Later, as Assistant Professor of Electrical Engineering he was in provisional charge of the department from 1890 to 1895, and as Professor of Electrical Engineering was in charge of the department at Cornell University from 1895 to 1905. He has been Professor of Electrical Engineering in charge of the department at Stanford University from 1905 to the present date.

Professor Ryan is one of the outstanding figures in the scientific and engineering phases of the electrical industries.

He is a pioneer and has distinguished himself as an investigator.

In 1890, he published a theory of the alternating current transformer which is generally regarded as establishing a basis mot theretofore available for proper design. He made substantial contributions to the theory of armature reaction in direct current machinery, and the pole face winding considered a requisite to the ultimate development of this type of machinery is credited to him. His paper containing the results of a thorough scientific investigation of the law of corona is regarded as establishing a basis for the treatment of air as a dielectric and for many publications that followed.

Professor Ryan was among the first to study and to report upon the nature of brush discharges at sustained radio frequencies, a matter of fundamental importance in the design of radio stations of high power. He has contributed largely to our understanding of the behavior and proper utilization of dielectrics for high voltage insulation purposes.

At Stanford University he has developed a laboratory for the study of high voltages which is a recognized center for the study of phenomena relating to the insulation of high voltage, high power transmission lines. In collaboration with others, he is the author of an important text book on alternating currents and, individually, or with others, of numerous papers or discussions on topics relating to electrical engineering.

During the war he was Director of the Pasadena Anti-submarine

Laboratory of the National Research Council for the Navy.

Among his other activities are the following: Juror,
Board of Awards, World's Fair, Chicago, 1893, and Panama-Pacific
International Exposition, San Francisco, 1915. Appointed by the
United States Government a member of the International Chamber
of Delegates to the International Electrical Congress, St.Louis,
1904. He has been a member of the Board of Consulting Engineers,
for the Power Development of the Los Angeles Aqueduct from 1909
to the present.

Professor Ryan's activities in the Institute of Electrical Engineers include the Vice Presidency from 1896-1898, and appointment as Honorary Vice President, 1915, "to act as special honorary representative and officer of the Institute on the Pacific Coast during the Panama-Pacific Exposition." He is a member of many leading scientific and technical societies including the National Academy of Sciences.

I have been acquainted with Professor Ryan for many years and I have come in contact with his engineering and scientific work in many ways. His distinguished accomplishments and abilities, in my opinion, meet perfectly the high requirements for the grade of Fellow and I recommend favorable action on his application.


